ARTICLES OF INCORPORATION

We, the undersigned natural persons of the age of twenty-one years or more at least two of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE ONE

The name of the corporation is Citizens' Environmental Coalition Educational Fund.

ARTICLE TWO

The corporation is a non-profit corporation.

ARTICLE THREE

The period of duration of this corporation shall be perpetual.

ARTICLE FOUR

This corporation is formed exclusively for and is hereby expressly limited to charitable and educational purposes within the meaning of section 501 (C) (3) of the Internal Revenue Code, leading to improvement of the environment by undertaking the following activities:

- A. Provide civic and professional groups with continuing educational opportunities for the development of common policy positions concerning matters affecting environmental quality;
- B. Provide member groups with an enlarged opportunity to share such fiscal, administrative, personnel, and expert resources as may be necessary to the conduct of such studies, inquiries, research, consultative and educational activities required in the development of recommendations concerning environmental quality control policies and programs;
- C. Provide member groups and other interested organizations with continuing information concerning public hearings, legislative, and governmental actions of relevance to environmental quality control policies, programs, and actions;
- D. Disseminate information beneficial to the public and community concerning the causes and prevention of environmental degradation through public discussion groups, forums, panels, lectures, or other similar educational programs;
- E. Accept and administer gifts, donations, and bequests, whether of money, personal property, or real estate, and otherwise to accumulate, administer and disburse funds to advance or achieve any of the above stated purposes;

- F. Encourage the continuing support of the public in all the activities of the Citizens' Environmental Coalition Educational Fund throughout the area served by this organization.

ARTICLE FIVE

The address of the initial registered office of the corporation is 5243 Beechnut, Houston, Texas 77035, and the name of its initial registered agent at such address is Stuart N. Henry.

ARTICLE SIX

The number of trustees constituting the initial board of trustees of the corporation is three (3), the minimum provided by law, and subject to such limitation, the number of trustees shall be fixed in the by-laws. The names and addresses of the persons who are to serve as the initial trustees are:

ARTICLE EIGHT

No part of the property of the corporation shall ever inure to the benefit of any trustee, officer or employee of the corporation or of any individual having a personal or private interest in its activities, nor shall any such trustee, officer, employee or individual receive or be lawfully entitled to receive any benefit from the operations of the corporation except reasonable compensation for services rendered in carrying out any of its purposes or as a proper beneficiary thereof.

ARTICLE NINE

The corporation shall not engage in, and none of its funds or property shall be devoted to, carrying on propaganda or otherwise attempting to influence legislation, participating in or intervening in any political campaign on behalf of any candidate for public office, or in any other activities or transactions which would prevent the corporation from obtaining and continuing its status as an exempt organization under the provisions of the Internal Revenue Code of 1954; and the use, directly or indirectly, of any part of the corporation's funds or property in any such activities or transactions is hereby expressly prohibited.

ARTICLE TEN

In the event of the dissolution of the corporation, any funds or property of any sort, real, personal or mixed, or rights thereto then owned by the corporation, or to which it may then be entitled, shall not be transferred to private ownership, but shall be charged with a charitable public trust which is entitled to an exemption under Section 501 (C) (3) of the Internal Revenue Code of 1954 and shall thereafter be transferred or conveyed for one or more exempt purposes to one or more domestic or foreign corporations, societies or organizations engaged in activities substantially similar to those of the dissolving corporation, pursuant to a plan of distribution adopted by the board of trustees.
